Accordingly, the following is an oral summary of the financial terms of the employment agreement:

The term of the agreement is January 19, 2021 through June 30, 2023, unless terminated earlier as provided for in the agreement

- The Assistant Superintendent's base salary shall be \$152,638 payable in equal monthly installments
- The Assistant Superintendent shall receive the master's stipend for \$1,416 as well as the doctoral degree stipend for \$2,835
- The Assistant Superintendent will be entitled to the same health and welfare benefits that are offered to other certificated management employees
- The Assistant Superintendent shall receive a \$200 monthly stipend for business use of her personal cell phone
- Actual and necessary costs for business related expenses incurred due to travel outside of District boundaries, will be reimbursed upon submission of appropriate receipts as ordinarily required of any employee seeking reimbursement. (A monthly mileage stipend of two hundred dollars (\$200). The District requires the Assistant Superintendent have an automobile available at all times for her use in the discharge of her duties)
- Assistant Superintendent shall have a work year of 220 days. She will accrue twenty (20) vacation days annually
- District agrees to pay the Superintendent's membership dues in the Association of California School Administrators (ACSA)
